



## ST HUGH'S FOUNDATION FOR THE ARTS SEEKS NEW TRUSTEES

The **St Hugh's Foundation** invites applications from candidates who are interested in joining our team of Trustees.

### **About the Foundation:**

The **St Hugh's Foundation** is a registered Charity, formed in 1991. A series of award schemes have been offered annually since 1992 to artists and arts organisations living/working full or part-time in Lincolnshire (including North and North East Lincolnshire), the East Riding of Yorkshire or the City of Hull. In 2016 we awarded Arts Awards to Fiona Caley (a photographer based in Holderness), Kate Genever (a visual artist working in Uffington) and Adele Howitt (a ceramicist based in Hornsea) having re-launched our Awards programme in that year and after receiving an unprecedented number of applications.

Briefly, our stated objectives in our Trust Deed are:

- To seek to improve standards in practice, presentation and management of the arts by supporting initiatives to develop public knowledge and individual ability and skills
- To encourage initiatives to develop education and training in the practice, presentation and management of the arts
- To encourage the development of knowledge and understanding in the arts in the geographical area we cover; also supporting artists from the region to work nationally and internationally

Following a [period of review in 2015](#), we came up with a new mission statement:

- To be artist-led and responsive to the community we serve.
- To invest in high quality work that shows ambition and clarity of purpose.
- To support all artists, at all stages of their practice.

### **Join our team**

We invite expressions of interest from individuals who will:

- take part in 3 meetings per year. Meetings are held in different locations around the geographical area we cover.
- contribute to shortlisting and interview of Award applicants in the future
- share knowledge, skills and experience, and keep updated on developments in their specialist interest in the arts within the Foundation's area of benefit
- take an active interest in the management of the Trust, contributing to decision-making between meetings where necessary, and, where appropriate, acting as an informal mentor to Award recipients

Successful applicants will be asked to sign up to a (renewable) 3-5 year term (length of term to be agreed with selected applicants). Trustees are unpaid, but travel expenses will be covered.

The St Hugh's Foundation for the Arts recognises that our area of benefit is culturally diverse, and welcomes proposals from all applicants. We would particularly like to strengthen our team's current working knowledge of visual arts, music, literature, marketing and PR (including social media). Additionally, we would welcome expressions of interest from people from minority ethnic communities, from people with a disability(ies) and from people living and working in East Yorkshire and Hull as these groups are under-represented within the existing group of Trustees.

- An outline (no more than 1 side of A4) of your reasons for applying, telling us what you feel you can bring to the work of the Foundation and what you would hope to gain from it.
